## 1 Service access credentials

To access the services, the user must be in possession of one of the following credentials:

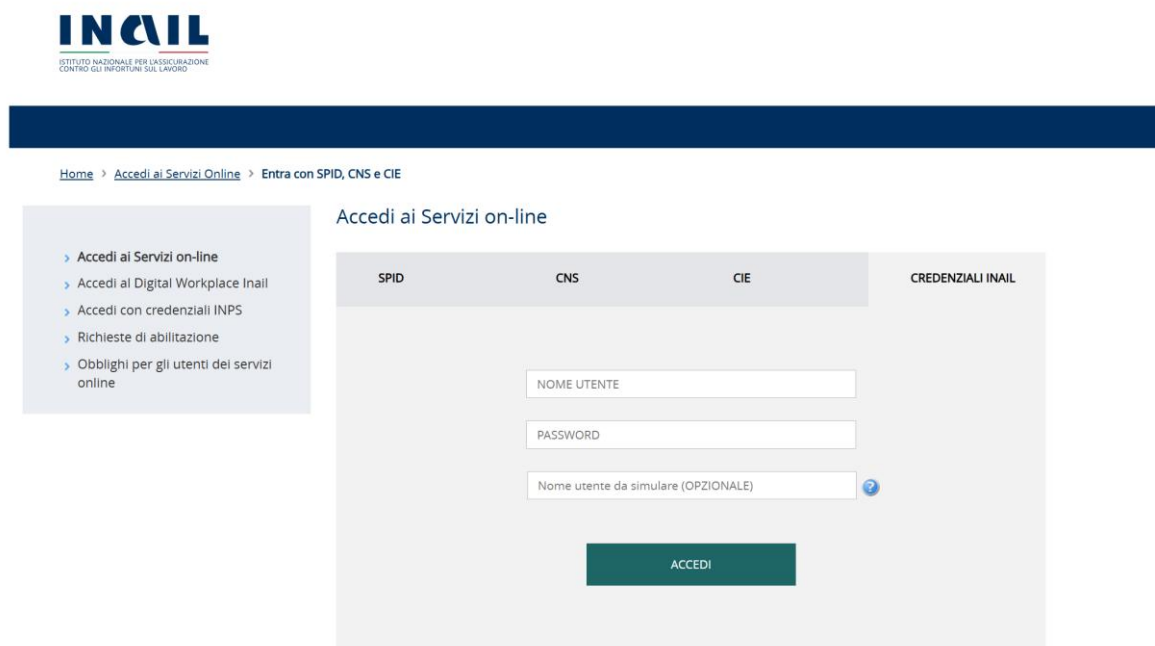
1. The national services card (CNS).  
In this case, the user must insert the Smart Card into the reader, press the Continue button and enter the PIN for the Smart Card.
2. SPID credentials.  
In this case, the user must click the "Enter with SPID" button, choose their Identity Provider (Infocert, Poste or Tim) from the list, and complete the authentication. Users accessing with SPID credentials are automatically recognised on Inail systems as a "User with single service credentials" and have access to the online services available to that user category.
3. Electronic Identity Card (CIE).  
In this case, the user must select "**Log in with CIE**".

## Homepage

The insurance provided under law 493/1999 protects people aged **between 18 and 67 years**, who **exclusively and habitually, with no employment relationship and without pay**, perform a range of activities for the purpose of taking care of people and of the domestic environment where the household of the insured party lives, against **accidents in the home** which result in permanent incapacity.

The services make it possible to:

- present the registration application and request the PagoPA payment notice to pay the premium
- present the registration application and self-declaration to take advantage of exemption from payment of the premium. The exemption applies to people who, in the year prior to the year of the application, declared a gross income for personal income tax (IRPEF) purposes not exceeding **€4,648.11** and who belong to a household whose total gross income for personal income tax (IRPEF) purposes does not exceed **€9,296.22** (the total income of the household is made up of the incomes of its individual members, as set out by **article 3 of Prime Ministerial Decree 159/2013**). In all cases of exemption from presentation of the declaration of income, the income requirements indicated apply to gross income for personal income tax (IRPEF) purposes received in the second year prior to the year of the registration application. The self-declaration must be presented every year **by the 31st January** to renew the insurance.
- send the cancellation request if the insurance requirements no longer apply
- view the payment notices/Unique Payment Identifiers number to pay from the 1st to the 31st January to renew the insurance (notice available from 1st January each year for individuals already registered during the previous year, including those exempted from the premium) or the number of payment notices / Unique Payment Identifiers processed following the presentation of a registration application and payment notice request.
- view and print the receipts for notices paid online using PagoPA
- see your own insurance overview and payments
- send reports and request information using the "Inail responds" service.

**For registration with payment notice, it is necessary to:**

- select the menu option 'Registration application and payment notice request';
- if necessary, edit the residence and the email and telephone contact details;
- insert the date on which the requirements were satisfied, i.e. the date since when you have been in possession of the requirements for registration for insurance against accidents;

after making the application, the user will receive an email with a receipt for the registration application and an email with the payment notice.

**For registration with a self-declaration, it is necessary to:**

- select the menu option 'Registration and renewal application with self-declaration';
- if necessary, edit the residence and the email and telephone contact details;
- confirm the insurance requirements and the date of registration for insurance;
- enter your income requirements (not exceeding €4648.11) for the two years prior to the current year;
- if necessary, enter the identifying details and income requirements for each member of the household;
- confirm the declaration

after making the application, the user will receive an email with a registration receipt

### 3 Using the services

The services make it possible to:

- Present the registration application and request the payment notice to pay the premium;
- Present the registration application and self-declaration to take advantage of exemption from payment of the premium. The exemption applies to people who, in the year prior to the year of the application, declared a gross income for personal income tax (IRPEF) purposes not exceeding €4,648.11, and who belong to a household whose total gross income for IRPEF purposes does not exceed €9,296.22 (the total income of the household is made up of the incomes of its individual members, as set out by article 3 of DCPM 159/2013). In all cases of exemption from presentation of the declaration of income, the income requirements indicated apply to gross income for personal income tax (IRPEF) purposes received in the second year prior to the year of the registration application. The self-declaration must be presented by 31<sup>st</sup> January every year to renew the insurance;
- Send the cancellation request if the insurance requirements no longer apply;
- Cancel registration with payment notice;
- Cancel the registration with payment exemption made by mistake and convert it into a registration with a payment notice;
- Modify the data entered in the self-declaration to benefit from the exemption from payment of the contribution;
- View the payment notice number/Unique Payment Identifier to be paid between 1<sup>st</sup> and 31<sup>st</sup> January to renew the insurance (notice available from 1<sup>st</sup> January each year for individuals already registered during the previous year, including those exempted from the premium) or the payment notice number/Unique Payment Identifier processed following the presentation of a *registration application and payment notice request*;
- View and print the receipts for notices paid online using PagoPA;
- See your own insurance overview and payments;
- Send reports and request information using the "Inail responds" service.

### 3.1 "Registration application and payment notice request" service

The "**Registration application and payment notice request**" service allows the registration application to be compiled and submitted and the payment notice to be requested.

This service must be used both by people registering **for the first time** and by those who, despite having registered for insurance in the past, **did not renew their insurance** by paying the premium the previous year or requested **cancellation of the insurance** because the requirements no longer applied.

The system checks whether a payment notice has been processed for the current year and, if so, and if the date on which the user has accessed the service falls between 1<sup>st</sup> and 31<sup>st</sup> January, it displays the following message:

"You have already been registered for insurance. You can view the payment notice number/Unique Payment Identifier and pay the premium online by 31<sup>st</sup> January to renew insurance for the current year through PagoPA, using the "*View the payment notice for insurance renewal*" service.

The payment notices for renewal of insurance are also processed for insured parties who are exempt from payment of the premium (which is paid for by the State in this case); this is because, if the income requirements imposed by the law no longer apply, these individuals must pay the annual premium of €24 in order to renew the insurance.

The service is structured into **Section A - data for the applicant**, with the identifying details of the person who must register for insurance, and **Section B - insurance requirements**.

- **Section A - Data for the applicant**

The following data are required:

- o **identifying details:** tax code, name, surname, date of birth, sex, municipality of birth, province;
- o **residence data:** street, address, number, province, municipality, postcode;
- o **contact details:** email address, confirmation of email address, certified email address, confirmation of certified email address, telephone number 1, telephone number 2;
- o **privacy and personal data processing policy:** accept the policy and give consent to data processing.

The service automatically populates the "**identifying details**" part with the tax code, name, surname, date of birth, sex, municipality of birth, and province of the municipality of birth which were indicated by the user when the single service credentials were issued and entered into Inail's profiling system when the user registered themselves.

These data cannot be edited by the user.

The **residence data** and **contact details** must be updated by the user if they have changed from those given when registering.

In fact, confirmation of the correct delivery of the registration application (receipt) and the payment notice will be sent to the email/certified email address indicated by the user on this screen.

After entering their **residence data** and **contact details** and viewing the privacy and personal data processing policy, the user must click "I accept the policy described above and give my consent to the processing of personal data".

Once all the fields have been filled in, the user clicks the "Save/Next" button to move on to completing Section B.

• **Section B - insurance requirements**

In this section, the user must declare, under their own responsibility, that they are in possession of the insurance requirements imposed by law for registration for insurance against domestic accidents, and must indicate in the field provided the date from which they have been or will be in possession thereof (**date of satisfaction of the insurance requirements**).

The following situations may arise:

- 1) the user declares within the service that they will satisfy the insurance requirements on a date **subsequent** to the day on which they are filling out and submitting the registration application.

Indeed, article 5, paragraph 4 of Italian Interministerial Decree 13 November 2019 requires that the registration application be presented at least 2 days prior to the date of satisfaction of the insurance requirements, partly for the purposes of fulfilling the obligation to pay the premium, which must be paid in a single lump sum on the date when the insurance requirements are satisfied.

If the user gives a later date, the €24 payment notice processed by the system shall show the payment deadline as 10 days after the date indicated by the user, as article 5, paragraph 5 of the aforementioned decree has established that payment of the premium is considered to be on time if made within 10 days of satisfaction of the requirements.

Dates further than 30 days in the future cannot be entered.

- 2) the user declares within the service that they have satisfied the insurance requirements **on the same** date as the day on which they are filling out and submitting the registration application.  
In this case, the €24 payment notice processed by the system shall also show the payment deadline as 10 days after the date indicated by the user.
- 3) the user declares within the service that they have satisfied the insurance requirements on a date **earlier** than the day on which they are filling out and submitting the registration application.

In this case, the payment notice processed by the system shall show the payment deadline as 10 days after the date on which the registration application was submitted, and the premium of €24 per year shall be increased by the additional sum provided for by article 6 of Italian Interministerial Decree 13 November 2019, calculated based on the date on which the insurance requirements were satisfied, as indicated by the user in the registration application.

If the application is presented after the date on which the insurance requirements were satisfied, the insurance coverage still begins on the day after the payment of the premium, as the principle of automatic entitlement does not apply to insurance against domestic accidents (article 9, paragraph 3 of law 493/1999)

The amount of the additional sum is equal to half the amount of the premium itself (€12) if 60 days elapse between the payment deadline date and the date on which the insurance requirements were satisfied.

If more than 60 days elapse between the payment deadline date and the date on which the insurance requirements were satisfied, the amount of the additional sum is equal to the amount of the premium itself (€24).

In any case, it is not permitted to enter dates more than 5 years earlier than the year (the premium is annual) of the date on which the insurance requirements were satisfied (the five-year time limit established by article 3, paragraph 9, letter b) of law No. 335 of 08 August 1995 in relation to all insurance premiums is applied).

The premium must be paid by the date indicated in the notice.

For all years following initial registration, the insurance premium must be paid in a single lump sum by 31 January every year to renew the insurance, always provided that the insurance requirements continue to apply.

For all years following initial registration, insured parties are also obliged to inform Inail if any of the insurance requirements no longer apply, using the online "*Send insurance cancellation request*" service.

### 3.2 Registration and renewal application with self-declaration" service

The "Registration and renewal application with self-declaration" service allows the registration application to be compiled and submitted by individuals in possession of the income requirements provided for by the law, which entitle them to exemption from payment of the €24 premium. The State pays the premium for these users.

This service must be used by individuals in possession of the income requirements for exemption from payment of the premium registering for insurance for the first time; as well as by those who must renew their insurance by 31<sup>st</sup> January each year, again with exemption

from payment, as both the insurance and income requirements continue to apply.

In fact, article 4, paragraph 8 of Italian Ministerial Decree 13 November 2019 establishes that, as of 1<sup>st</sup> January 2020, the application attesting to the existence of the income requirements must be presented electronically not only upon the initial registration, but by 31<sup>st</sup> January every year for as long as the income requirements entitling the applicant to exemption from payment of the premium continue to apply.

The service is split into the following sections:

Section A - data for the applicant, containing the identifying details of the person registering for insurance

Section B - insurance requirements

Section C - income requirements of the applicant

Section D - income requirements of members of the household

Section E - total gross income of the household for personal income tax (IRPEF) purposes

If the user is registering for insurance **for the first time** (initial registration), the following situations may arise:

- a) the user declares within the service that they will satisfy the insurance requirements on a date **subsequent** to the day on which they are filling out and submitting the registration application.

Indeed, article 5, paragraph 4 of Italian Interministerial Decree 13 November 2019 requires that the registration application be presented at least 2 days prior to the date of satisfaction of the insurance requirements.

If the user gives a later date, the insurance shall begin on the date on which the insurance requirements were satisfied, as indicated by the user.

Dates further than 30 days in the future cannot be entered.

If the registration application is submitted on a date later than the date on which the insurance requirements were satisfied, the insurance shall begin on the day after Inail receives the application, as the principle of automatic entitlement does not apply to insurance against domestic accidents (article 9, paragraph 3 of law 493/1999).

- b) the user declares within the service that they have satisfied the insurance requirements on the **same** date as the day on which they are filling out and submitting the registration application.

In this case, insurance shall also begin on the day after Inail receives the application, as the principle of automatic entitlement does not apply to insurance against domestic accidents.

- c) the user declares within the service that they have satisfied the insurance requirements on a date **earlier** than the day on which they are filling out and submitting the registration application.

In this case, insurance shall also begin on the day after Inail receives the application, as the principle of automatic entitlement does not apply to insurance against domestic accidents.

If the user is registering **to renew their insurance** and **compiles and submits** the registration application on a day between 1<sup>st</sup> and 31<sup>st</sup> January, they must indicate **1<sup>st</sup> January** in the field provided as the date on which the insurance requirements were satisfied.

In the case of renewal, insurance must begin on that date.

The system checks whether the user was insured during the previous year and is, therefore, presenting an application to renew their registration (i.e. it is not the initial registration).

The following is the screen shown for **Section B - insurance requirements**:

**Figure 8 – Section B, Insurance requirements**

The user selects all the insurance requirements requested and enters the date from which they declare that they have been/will be in possession of these requirements.

Afterwards, they press the "Save/Next" button to move on to completing Section C.

The following is the screen shown for **Section C - income requirements of the applicant (the person who must obtain insurance)**:

**Figure 9 – Section C**

In section C, the person who must obtain insurance declares, pursuant to article 46 of Presidential Decree 445/2000, that their gross income for personal income tax (IRPEF) purposes **declared** in the year **prior** to the year of the registration application being filled out (referring therefore to the tax year before that again) is equal to \_\_\_\_\_ euro, not exceeding €4,648.11 per year.

If the person who must obtain insurance did not present a declaration of income in the previous year, because they were exempt from this obligation under the applicable legislation, they must declare that their gross income for personal income tax (IRPEF) purposes **received** in the **second year prior** to the year of the registration application being filled out was equal to \_\_\_\_\_ euro, not exceeding €4,648.11 per year.

The two declarations are provided as alternatives to each other.

Article 4, paragraph 2 of Italian Ministerial Decree 13 November 2019 establishes that the insurance premium is paid by the state for those individuals who are in possession of **both** the below requirements:

- a) in receipt of gross personal income for personal income tax (IRPEF) purposes not exceeding **€4,648.11** per year;
- b) membership of a household whose total gross income for personal income tax (IRPEF) purposes does not exceed **€9,296.22** per year.

Article 4, paragraph 4 of Italian Ministerial Decree 13 November 2019 establishes that, in determining the existence of the income requirements entitling an applicant to exemption from payment of the premium, reference is made to the total gross income, both personal and that of the household, **declared for personal income tax (IRPEF) purposes in the year prior to the presentation of the self-declaration.**

On the online service the year of the declaration, which refers to the year prior to when the self-declaration is presented, is set automatically. The tax year, which refers to the year prior to that of the declaration of income, is also set automatically.

For example, if the user is presenting a registration application with self-declaration on 15 January 2020, the year of the declaration of income for IRPEF purposes shown by the service will be 2019, while the tax year shown will be 2018.

For individuals exempt from the presentation of the declaration of income, reference is instead made to the total gross income for IRPEF purposes, both personal and that of the household, **received in the second year prior to the presentation of the self-declaration.**

On the online service the year when the income was received, which refers to the second year prior to when the self-declaration is presented, is set automatically.

For example, if the user is presenting a registration application with self-declaration on 15 January 2020, the year when the income was received for IRPEF purposes shown by the service will be 2018.

**For the purposes of meeting the income requirements that entitle one to an exemption from paying the insurance premium, reference must not be made to the ISEE.**

The user proceeds by pressing the "Save/Next" button in order to move on to completing Section D.

The "Household member" screen is split into three sections: **Identifying details**, **Residence data** and **Income requirements**. The surname, first name, date of birth, sex, country of birth, province and municipality of birth and tax code of the member of the household must be entered into the **Identifying details** section.

Moreover, the "Relationship to the applicant" must be selected from the following options:

S = Spouse

C = Minor child

MA = Minor in pre-adoptive foster care

FC = Cohabiting adult child

AC = Non-cohabiting adult child supported for personal income tax (IRPEF) purposes

O = Other person in the household

The **Other person in the household** category includes individuals other than a spouse, minor child, child in pre-adoptive foster care, cohabiting adult child and non-cohabiting adult child supported for personal income tax (IRPEF) purposes. In practice, this may refer to:

- unmarried cohabiting parents who are considered to belong to the same household for ISEE purposes. The parent making the declaration must indicate the other as "other person in the household" in the ISEE declaration;
- a separated spouse who has not moved into their own residence, and is therefore considered within the family and household of the other spouse, with the result that they must be included on the declaration as "O – other person in the household".

The address where the member of the household lives must be entered on the **Residence data** screen.

Finally, the self-declaration regarding the gross income for IRPEF purposes **declared** by the member of the household in the year prior to the applicant's presentation of the registration application must be entered in the **Income requirements** section.

In all cases of exemption from presentation of the declaration of income, the self-declaration regarding the gross income for IRPEF purposes **received** by the member of the household in the second year prior to the year of the applicant's presentation of the registration application must be entered.

If the member of the household is a minor child, select **No income**.

In terms of the years displayed by the service, refer to the description given in Section C – income requirements of the applicant.

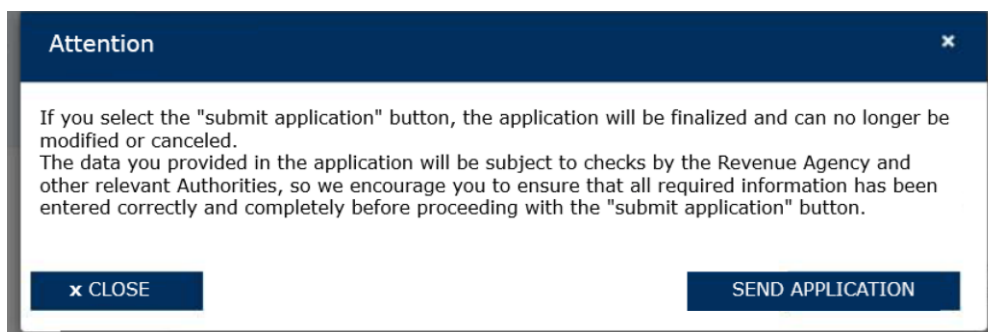

### 3.3 Send Insurance Cancellation request

The "Send insurance cancellation request" service allows users to inform Inail if they are no longer in possession of the insurance requirements, and therefore to request cancellation of the insurance.

For all years following initial registration, insured parties are in fact obliged to inform Inail if any of the insurance requirements no longer apply (art. 5, paragraph 9, Italian Decree 13 November 2019).

It is not necessary to submit this request after the insured party reaches the age of 67, as Inail automatically discontinues the insurance position on the 31<sup>st</sup> December of that year. As the premium is annual and cannot be split into parts, any insurance held by individuals turning 67 remains valid until the next annual deadline for the premium (art. 2, paragraph 2 of Italian Ministerial Decree 13 November 2019).

### 3.4 "Cancel registration" service

The "Cancel Registration" service allows the user to:

- Cancel a registration application with a payment notice; cancellation is possible only as long as the Payment Notice/IUV generated by the system—based on the data provided in the registration application to be canceled—has not yet been paid.
- Cancel a registration application with a substitute declaration; cancellation is possible only if the user has not been included in the annual random checks for income verification carried out through the Revenue Agency. During the cancellation process, a new registration application with a payment notice will be created at the same time and sent to the user by email.

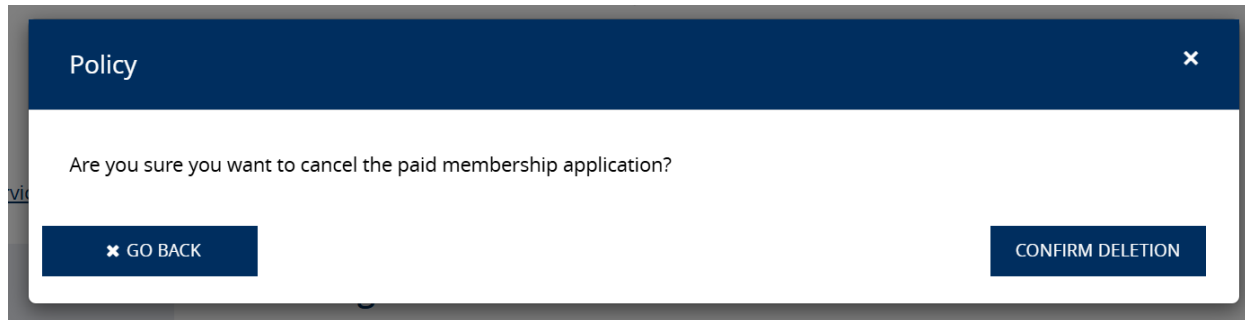

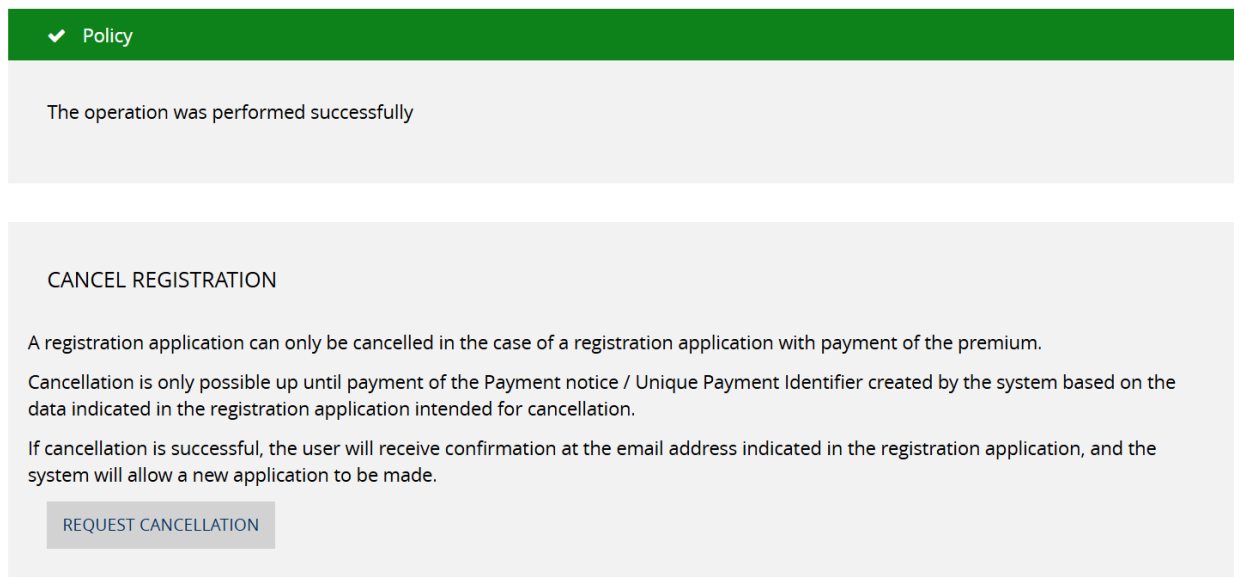


**Figure 18 – Request cancellation**

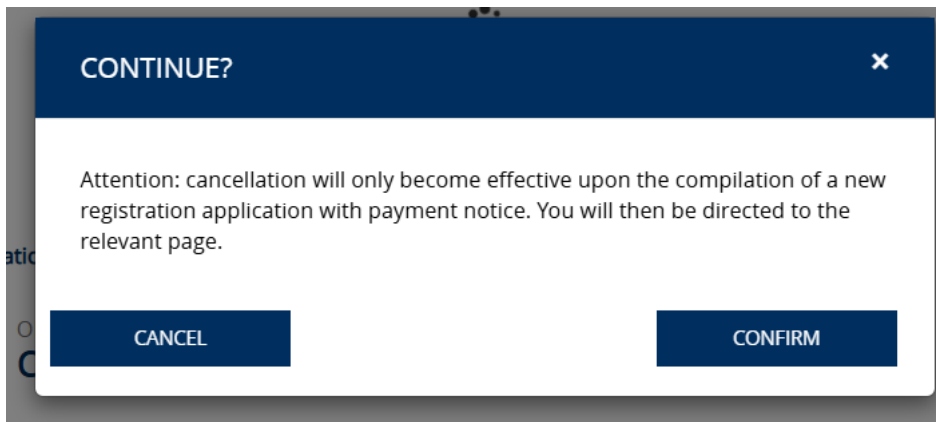

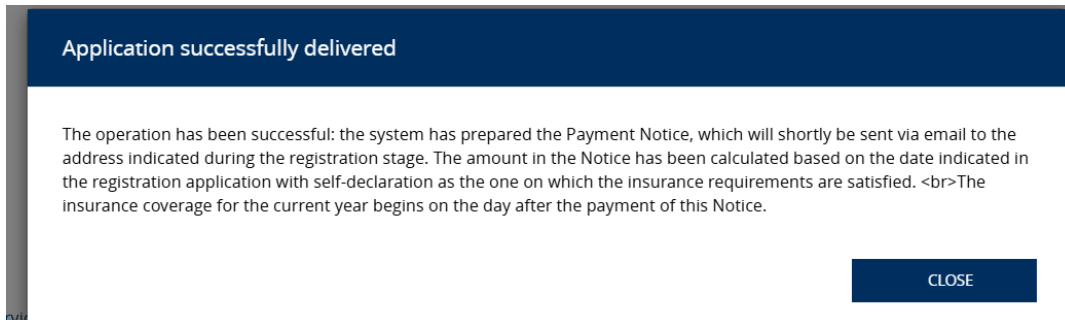

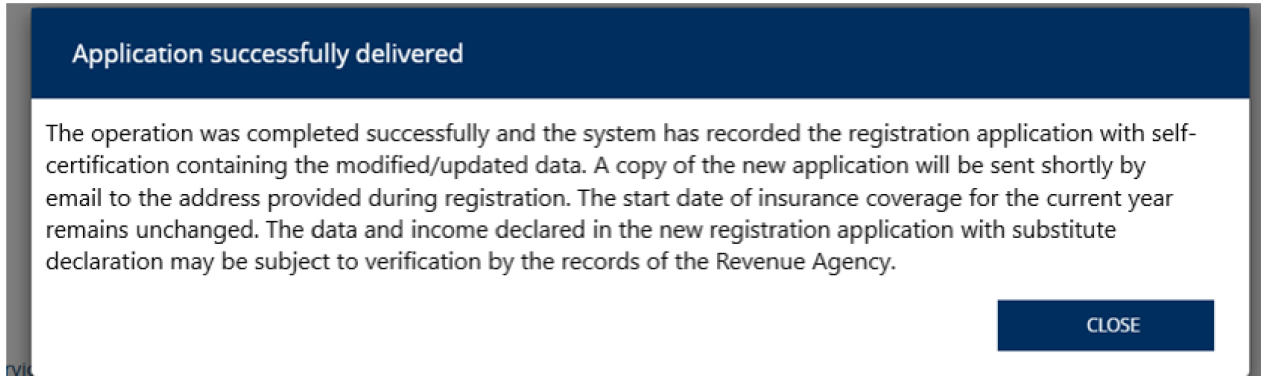



The "RECEIPT" icon allows the electronic receipt to be displayed, if present.

The "CERTIFICATE" icon allows the certificate of registration for insurance against domestic accidents to be displayed for the years 2020 and 2021, where a completed registration is present.

### 3.7 "View the payment notice for insurance renewal" service

With the "View the payment notice for insurance renewal" service, the user can view the payment notice number/Unique Payment Identifier to be paid between 1<sup>st</sup> and 31<sup>st</sup> January to renew the insurance, or the payment notice number/Unique Payment Identifier processed following the presentation of a registration application and payment notice request.

The PagoPA payment notice for the annual renewal of the insurance against domestic accidents is processed in December for each insured party, including those individuals exempt from payment of the premium, if the interested party did not give timely notice that the insurance requirements no longer apply and is therefore registered for insurance.

The user can also use the link to the PagoPA system to pay the premium online.

**Starting from 1 January 2023, all IUVs processed by INAIL systems are of the so-called "incremental" type.**

**Therefore, if payment is made after the date indicated on the PagoPA notice, the amount the insured person is required to pay will be automatically updated with an additional sum calculated based on the number of days of delay (that is, an extra €12 will be added to the €24 premium if the delay is up to 60 days, or €24 if the delay exceeds 60 days).**

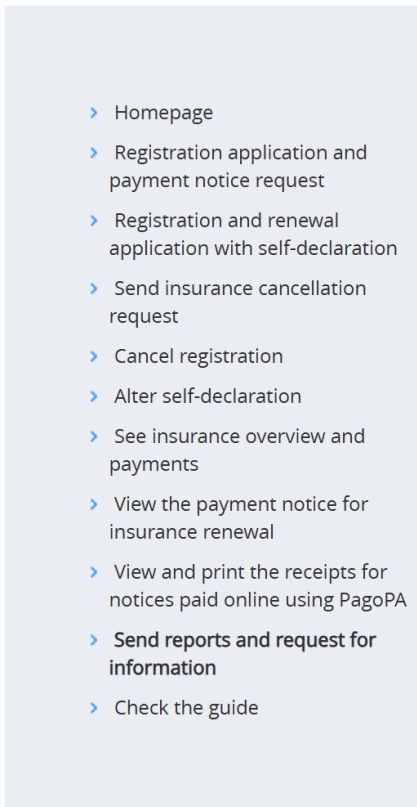
